Arizona Attorney General and Riverview LLP reach agreement to support water access and conservation in Arizona's Sulphur Springs Valley

Today, Arizona Attorney General Kris Mayes and Riverview LLP announced a voluntary agreement to improve domestic water access for residents in the Sulphur Springs Valley of Cochise County, Arizona.

Under the Agreement, Riverview will implement a plan to continue its water conservation efforts in Cochise County, as well as contribute \$11 million to a pair of new assistance funds that will support Riverview's neighbors and other residences in the Sulphur Springs Valley facing water-related challenges.

As part of the agreement:

- Riverview will temporarily transition 2,000 acres from row-crop production to other uses. This will occur in phases over 12 years.
- Riverview will commit \$5.5 million over 20 years for the benefit of local homeowners, schools, or water supply systems. These dollars will be available to eligible applicants within 1.6 miles of a Riverview well who have a need for water supply assistance.
- Riverview will contribute \$5.5 million to a separate fund administered by a non-profit entity for the benefit of applicants located within the Sulphur Springs Valley, but more than 1.6 miles from a Riverview well. These dollars will be managed by the non-profit entity and an advisory board, though the agreement stipulates that well-drilling and water supply efforts will be prioritized.

Riverview statement:

"Riverview values stewardship of the land and water – a healthy environment is essential to everything we do. That's why we have invested and innovated over the past decade to ensure our farms in Cochise County are equipped with the best available technology to conserve water, as well as voluntarily reduced water use. Riverview also recognizes the water challenges facing the Sulphur Springs Valley, and we want to be part of the solution. Attorney General Mayes has helped highlight these challenges, and we appreciate her efforts in identifying these tangible steps to help Arizonans in need. By working together with state and local leaders, we can strengthen local water access and build a more sustainable future."
